## GIVE FROM AN IRA

Congress has now made the IRA Charitable Rollover permanent. This means that individuals who are 70 ½ or older can make gifts of up to \$100,000 directly from their IRA accounts to one or more qualified charities, without paying federal income tax on the withdrawal. If you wish to make a gift to benefit the Operating Fund (i.e., paying your pledge) or to the Saint Barnabas Foundation you may choose to make a Qualified Charitable Distribution.

Here are the specifics:

Donors must be age 70 ½ or older at the time the gift is made.

- Donors must request a direct transfer of funds to a qualified charity, it is important NOT to withdraw the funds before making a gift.
- Gifts cannot be used to fund a gift annuity or charitable remainder trust.
- Each donor may give up to \$100,000 per year.
- Gifts can be used to satisfy the donor's required minimum distribution.
- Donors who choose to exclude the distribution from income on their federal tax returns will not receive a charitable income tax deduction.
